In accordance with the Board's *Procedural Order Re Notice of Second Remand Status Conference, Request for Additional Comments, and Proposed Schedule*, issued on March 2, 2015, Vermont Gas Systems, Inc. ("Vermont Gas") submits the following comments.

With respect to the second remand proceeding, Vermont Gas reiterates its previous position on scope as articulated in the company's filings dated January 16, 2015, and January 21, 2015. Specifically, under Vermont Rule of Civil Procedure 60(b) the appropriate scope of review should be evidence directly related to VGS' revised cost estimate.

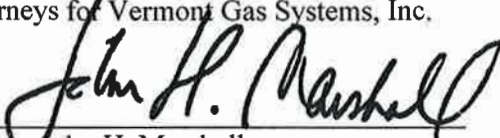
