PROCEDURAL ORDER RE: RESPONSE TO INTERVENTION MOTIONS

On November 10, 2016, the Vermont Public Service Board (“Board”) issued a Prehearing Conference and Scheduling Order in this proceeding. That Order designated the week of January 2, 2017, as the week in which a workshop would be held to provide non-petitioning parties and potential intervenors an opportunity to ask the petitioner questions about its proposed project. A deadline for motions to intervene was established for 11 calendar days after the workshop, with responses due seven calendar days after the motion filing deadline.

Based on the level of interest in this proceeding, the Board anticipates that interested persons and entities may file motions to intervene without waiting for the arrival of the workshop date or intervention deadline. In establishing the schedule set forth in our November 10th Order, it was not our intent for responses to intervention motions filed in advance of the workshop or intervention deadline to be postponed beyond the time limits established in Vermont’s Rules of Civil Procedure.¹

Accordingly, we clarify that responses to motions to intervene shall be filed no later than 15 calendar days after such motions are filed or by the deadline established in the November 10th Order, whichever is earlier.
