**SECOND PROCEDURAL ORDER RE: RESCHEDULED WORKSHOP AND SCHEDULE**

**I. Introduction and Background**

By Order dated December 19, 2016, the Vermont Public Service Board (“Board”) established January 3, 2017, as the date for a workshop in this proceeding.

However, that workshop was cancelled due to inclement weather and the possibility of hazardous driving conditions.

Attempts by the Board to set a new date for the workshop during the weeks of January 9 and 16, 2017, were unsuccessful due to scheduling constraints of many of the parties.

On January 6, 2017, the Board issued an Order seeking recommendations on a new date, time, and location for the workshop.

On January 17, 2017, recommendations were filed by Swanton Wind, LLC (“Swanton Wind”), the Northwest Regional Planning Commission (“NRPC”), the towns of Swanton and Fairfield, Dustin and Christine Lang, and the Vermont Department of Public Service (“Department”).<sup>1</sup> Bruce and Sally Collopy also submitted comments via email.<sup>2</sup>

<sup>1</sup> The Department did not make any recommendations regarding the date, time, or location of the workshop but noted that it was unavailable to attend on January 24 and 25, 2017.

<sup>2</sup> The Collopy's did not make a specific recommendation regarding the date for the workshop, although they did express a preference for it to be held in the Swanton area and during the evening. They also requested that Swanton Wind bring several full-size copies of the project site plans. The Board believes that it would be helpful for Swanton Wind to bring such full-size copies and requests that it do so.

## II. Discussion

After careful consideration of the comments and recommendations filed on January 17, 2017, we have determined that the workshop will be held on Thursday, February 9, 2017, commencing at 5:00 P.M., at the Swanton Village Complex, 120 First Street in Swanton. The format of the workshop shall remain as described in the Board's December 19, 2016, Order in this proceeding.

We realize that the date we have selected does not accommodate all the individuals and entities that filed recommendations with us regarding the workshop. In particular, we are cognizant that the February 9<sup>th</sup> date presents a conflict for the NRPC and the Langs. While we would prefer to accommodate all commenting parties, the comments from both the NRPC and the Langs indicate that there are very few dates when they are available to attend a workshop over the course of the next several weeks. Additionally, February 9<sup>th</sup> is a date when Swanton Wind's expert consultants are available, as are representatives of both the Town of Swanton and the Town of Fairfield. We also note that the workshop is to allow non-petitioning parties and potential intervenors an opportunity to ask Swanton Wind questions about the proposed project to better understand project details in advance of initiating formal discovery or deciding on whether to seek intervention. Both the NRPC and the Langs have already intervened as parties in this matter and are represented by counsel to assist them in the preparation of any discovery requests they may have. Thus, and in order to not unnecessarily complicate the schedule for this proceeding, we have decided that the workshop will take place on February 9<sup>th</sup> as proposed by the towns.

Given the February 9<sup>th</sup> date for the workshop, the possibility of another weather-related cancellation remains. If the workshop is again cancelled, every effort will be made to reschedule it. However, the schedule set forth below, including the new intervention deadline, will not be extended solely because of such a cancellation.

### III. Schedule



Like the original schedule, this schedule also recognizes the possibility that there may be motions to intervene pending on the date the first round of written discovery is served on Swanton Wind. Accordingly, the schedule allows persons or entities that have such a pending motion to serve discovery on Swanton Wind. In the event the motion is granted, Swanton Wind shall respond to any such discovery. In the event such a motion is denied, Swanton Wind shall not be required to provide responses.
